Re: Response to FOI request - REAch2 Academy Trust FOI 039/06/2019

I refer to your request dated 8th June 2019 made under the Freedom of Information Act 2000, which was received on 10th June 2019 at REAch2 Academy Trust for records held by Copperfield Primary Academy. Your request sought:

I am requesting the following information under the Freedom of Information Act.
For each of the following four categories separately and for Copperfield Academy: full-time teachers with Qualified Teacher Status; full-time teachers without QTS; part-time teachers with QTS; part-time teachers without QTS.
The number of new teachers appointed for September 2018, including the number of NQTs;
The number of teachers employed at the school September 2018; the number of these teachers who had left by Christmas 2018; the number of new staff taking up post for January 2019; the number of staff who left between the beginning of January 2019 and Easter 2019; the number of new staff taking up post for the summer term after Easter 2019; the current number of resignations received for the end of Term 6.

I trust that this response fully answers your Freedom of Information request.


